



Pool & Slides Rules

Patrons are requested to cooperate in observing these rules and to obey the instructions of the Pools Staff.

Pool rules are intended to benefit all users to assure a safe and enjoyable experience. Pool staff will firmly, fairly and consistently enforce pool rules. Patrons violating swimming rules are subject to the revocation of their swimming privileges.

General Pools Rules

1. **Swimming is permitted only when a lifeguard is on duty. No exceptions.**
2. Patrons are prohibited from distracting the lifeguards.
3. Children 13 years of age or younger must be accompanied by a person 14 years of age or older.
3. Keeping in mind the family atmosphere, all swimmers must wear appropriate bathing suits.
4. "Cut-offs" are not allowed.
5. To maintain the water quality, PLEASE: have children wear an approved "swim diaper" or plastic cover and use toilette facilities as defecating or urinating in the water will result in closing the pool for an appropriate period of time for cleaning and sanitation.
6. To keep the pool a safe and pleasant environment, PLEASE eat, drink or play in the appropriate designated areas.
7. There is NO EATING OR DRINKING IN THE POOL.
8. Pool patrons are prohibited from restricted areas such as pump rooms, storage areas and lifeguard offices.
9. Persons with open wounds, bandages, blisters or any symptoms of a respiratory or communicable disease, are prohibited from entering the pool facility.
10. Leave pets, glass containers and chewing gum at home.
11. Smoking and Vaping are PROHIBITED from all areas of the Recreation Center, Fitness Center, parking lot, bathrooms and all HOA grounds.
12. Alcoholic beverages, illegal substances and weapons are prohibited in all pool facilities.
13. Refrain from loud music or other disruptive activity.
14. Walk; don't run in and around the pool facility.
15. No rough housing, aggressive behavior or profane language.
16. Do not throw other swimmers in the water, stand on the shoulders of other swimmers or hang on ropes and rails.
17. No Diving is allowed.
18. Balls, toys, floatables, water guns, etc. are allowed at the pool at lifeguards' discretion. Lifeguards may ask any item to be removed for safety reasons or upon their judgment.

19. Children wearing personal flotation devices must be accompanied in the pool by a person 16 years or older. It is recommended that all flotation devices used are US Coast Guard approved.
20. Swimming aids and other flotation devices are allowed at the discretion of the lifeguards.
21. Thunder breaks occur when pool staff hears thunder or sees lightning.
The pool will close and reopen 30 minutes after the last thunder or lightning occurrence.
If the skies are clear, the pool will reopen 15 minutes after the last occurrence.
22. Ten minutes before the hour, the lifeguard staff will call a "safety break"
All Patrons must exit the pool and remain at least three feet from the edge of the pool.
23. Lakes at Creekside HOA is not responsible for lost or stolen items.
24. PLEASE BE ADVISED: The Recreation Center, Pool and Fitness are monitored under surveillance 24/7. High definition cameras are recording in full color. The HOA will seek restitution for vandalism.

Slide Rules

Slides will only be operational when a lifeguard is on duty. No exceptions.

1. Swimmers must follow the instructions of the lifeguards.
2. Swimmers using the slide must be able to swim 25 yards without the use of personal flotation device.
3. Only one swimmer is allowed down the slide at a time.
4. No diving or jumping from the sides of the slides. Swimmer must keep all body parts within the flume.
5. Swimmers must exit the area immediately.
6. Do not go down the slide until the area is clear.
7. Parents or guardians may assist swimmers using the slide but are prohibited from riding down the slide with the child or holding the child while using the slide.
8. Minimum user height for all slides is 44".
9. Maximum weight per user is 250 pounds.
10. Children younger than 5 years of age must be supervised by an adult to use this slide.
11. Swimmers using slides must proceed feet first and on their backs. No kneeling, standing or stopping on the slide.
12. No flotation devices, tubes, swimming toys, masks, goggles, sunglasses or loose jewelry is allowed.
13. Swim wear with exposed zippers, buckles, rivets or metal ornamentation is not permitted.

WARNING: Failure to follow slide rules can result in serious injury to yourself and others and loss of your privilege to use slide.

CAUTION: For safety reasons, pregnant women and persons with heart conditions or back trouble should not ride the slide

General Pool Party Rules

Pool parties are only available to residents in good standing with the HOA. The member must be at least 21 years of age. Parties that will have guests less than 21 years of age must have 1 adult present for every 10 party guests.

1. No pool parties can be scheduled in conflict with neighborhood functions or swim team schedules.
2. Pool parties can be scheduled before, during or after pool hours and may not last past 11:00 PM on Friday and Saturday and 10:00 PM Sunday-Thursday without HOA approval. Parties during hours can be up to 20 people, and the resident must reserve and pay for 1 additional lifeguard. Parties larger than 21 guests must be scheduled after pool hours.
3. Pool parties may be scheduled on a Monday after 4 PM when the pool is closed as long as that Monday is not a legal holiday when the pool is open. (If the pool is open on Monday, then the party may be scheduled on the day the pool is closed during that week.) Pool parties scheduled for a weekday or weeknight should not last past 10:00 PM
4. Pool parties may not be held on Opening weekends, during the weekends of Memorial Day and Labor Day or on July 4th.
5. There is a 10-day advance requirement for booking, reserving, and payment for all pool parties. Bookings can be made at www.a-beautifulpools.com. Please select "What We Offer" and then "Pool Parties" For party requests with a 5-9 day advanced notice please contact the office directly. Please note that ABP holds the right to deny the request or charge an additional late booking fee of \$50.00 for a total of \$85.00 nonrefundable office set up fee depending on the availability of the facility and/or lifeguards.
6. A-Beautiful Pools requires a minimum notice of 5 days to cancel a party (except in the case of bad weather). Insufficient cancellation notice will result in NO REFUND of lifeguard charges.
7. There is a \$35.00 non-refundable set-up fee in addition to the cost of the lifeguards to be paid at time of booking. The set-up fee is not a deposit.
8. There are always three lifeguards for 1-50 people (swimmers or no); thereafter, one lifeguard for each additional 20 people.
- 9 Lifeguard pay is \$26.00 per lifeguard, per hour. This is to be paid in full at the time of booking. There will be NO REFUNDS if resident decides to end party early. Note: There will be an additional 1 hour, for 2 guards charge for

each party. This is for additional cleaning, prep and closing time for 30 minutes before and 30 minutes after the party. Resident will be allowed in the pool area for their own set up/clean up during that time as well.

10. Parties after school starts and pool is no longer opened full time are subject to a \$75.00 fee. This fee is for additional cleanings to have the pool in good order. No parties will be held after the pool closes for the season.

11. No alcohol shall be served. No glass containers.

12. Resident is responsible for all clean-up around the pool area after party

13. The Office Manager or Supervisor must approve specific lifeguard requests for pool parties.

FITNESS CENTER RULES

1. Access to the fitness center is by use fingerprint reader.
2. No persons under the age of 17 are allowed inside of the fitness center with adult supervision.
3. The exercise facility is for Lakes at Creekside Residents only. Each Resident may have one (1) guest. Residents are responsible for their guest and their actions. All guests must be accompanied by a Member and must follow the fitness center rules. The fitness center guest policy may be revoked or changed at any time by Association Management.
4. All persons using the exercise facility do so at their own risk.
5. Oils or lotions should not be used prior to or during workout. Please wipe off equipment after use.
6. Lakes at Creekside Homeowners Association does not employ a professional trainer for the fitness center, nor does the Lakes at Creekside Homeowners Association endorse any professional trainer. Any solicitation of such should be reported to Lakes at Creekside Homeowners Association.
7. Tobacco products and/or food are not allowed in the fitness center. There is a strict no smoking policy for the fitness center and the recreation center grounds.
8. Running, playing with equipment or misuse of the facility and/or the equipment will not be tolerated.
9. Individual radios and televisions may be used with headphones only.
10. The exercise facility will be available for use from 4:00am-10:00pm. Entry allowed by use of registered fingerprint only.
11. Shirt and appropriate gym shoes are required at all times. No heeled shoes or boot of any kind are permitted.
12. Residents are responsible for turning off the television, fans and lights when the fitness center is not in use.
13. Fitness center doors should remain closed at all times. If the temperature needs adjusting, Residents should contact the management company.
14. Animals are not allowed in the fitness center unless use is for aid in disability.
15. Lakes at Creekside Homeowners Association and management reserves the right to adjust or add any rules as needed. Additional fitness center rules may be posted at the fitness center or may be implemented without notice. Management reserves the right to refuse anyone the use of the fitness center. Failure to adhere to these rules may cause the loss of fitness center privileges.
16. Residents must be current with the HOA with no balance to maintain access to all amenities.
17. Lakes at Creekside Homeowners Association is not responsible for lost or stolen items.
18. Use of the Fitness Center is at your own risk.
